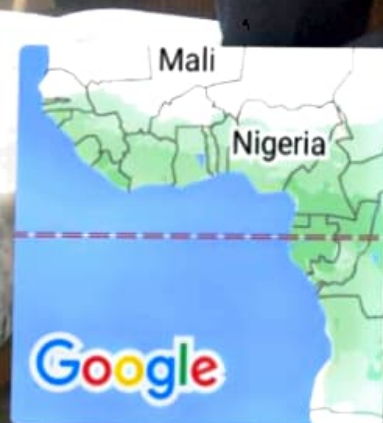

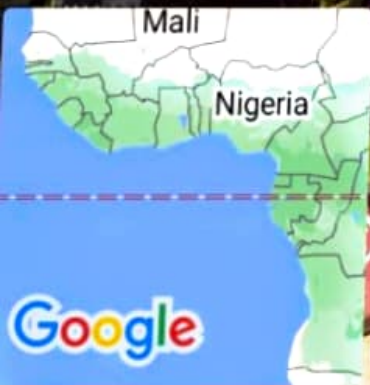

#### 6 JOINT ACTIVITIES


